## Action Plan C1

### Improving activities for young people

#### Background

The results from the Great Village Voice Questionnaire Survey show that, whilst 28% of respondents feel that social activities, events, clubs and societies for young children (up to age 11) are excellent or good, the equivalent figure for the 12-16 age group is only 8% (with no-one considering it to be excellent). Almost half the respondents (47%) feel that activities for the 12-16 age group are bad or in need of improvement.

A range of suggestions for potential activities or facilities was provided in the survey and in the House Parties and workshops.

## Action Plan C2

### Improving knowledge of ‘what’s on’

#### Background

The results from the Great Village Voice Questionnaire Survey show that only about half the respondents (49%) feel that they normally know what is going on in the parish. Whilst only 3% of respondents stated that they “never seem to know about what is going on”, some 48% answered “only sometimes”. A range of suggestions for how information about what is going on could be improved was provided in the survey and in the House Parties and workshops.

The most popular new facility or amenity which respondents to the Great Village Voice Questionnaire Survey said that they would use was 'occasional film shows'. This answer was provided by 57% of respondents and the suggestion occurred, unprompted, elsewhere in the survey as well as in House Parties and workshops.

#### Background

One of the most popular new facilities or amenities which respondents to the Great Village Voice Questionnaire Survey said that they would use was a 'directory of 'who does what' (talents and skills)'. This answer was provided by 50% of respondents and it occurred, unprompted, elsewhere in the survey as well as in House Parties and workshops. It was suggested that such a 'Directory' could draw upon the County

Council's Trading Standards 'Buy with confidence' directory and could also usefully include details of services and entitlements which are available to assist in improving the quality of life of residents.

## Action Plan C6

### Reducing the fear of criminal and anti-social behaviour

#### Background

The results from the Great Village Voice Questionnaire Survey reveal that there are worries about a number of crime and safety issues in the parish even though actual crime levels and instances of other anti-social behaviour are relatively low. Over half the respondents to the survey said that they were either very worried or slightly worried about vandalism (66%), about other anti-social behaviour (62%), about

crime in general (56%), about the safety of children (55%) and about the safety of the elderly (51%).

## Action Plan C7

### Reducing the fear of the safety of the electrified railway line

#### Background

The results of the Great Village Voice Questionnaire Survey show that there are worries about the safety of the electrified railway line. Whilst less than half the respondents were worried about this issue (56% saying that they were 'not worried' or 'not worried at all'), 21% were 'very worried' and 23% 'slightly worried'. Concerns about the safety of the crossing point on the footpath between the

Recreation Ground and the woods had been raised in Village Voice House Parties and workshops.

Only 5% of respondents feel that this is done 'very well', 46% said that they felt that it was done 'reasonably well' and 37% felt that it was done 'badly' (11% recorded 'no opinion' on this matter). A range of views (and ideas) on this matter had also been provided in Village Voice House Parties and workshops.

## Action Plan C9

### Retaining a Post Office in the village

#### Background

The results of the Great Village Voice Questionnaire Survey show that there was strong support for the village shop and Post Office: 85% of respondents said that the Post Office was an important amenity for the community with only 5% saying that it was not (10% had no opinion). But, since the survey, the shop and Post Office has been closed and a national review of the whole of the rural Post Office network has commenced.

## Action Plan C10

### Ideas for improvements to the Village Hall and other community buildings

#### Background

Comments made at House Parties, workshops and in the Great Village Voice Questionnaire Survey show that the Village Hall facility is a very valuable amenity, offering the opportunity for a wide range of community activities and events. Comments at House Parties in particular paid tribute to the people who had organised the provision of such a new and valuable asset (in 1996/97) and to the Committee that has managed the facility since then. A number of comments for potential improvements were also made. One in five households (20% of respondents) said that “improving the times that residents can use the Village Hall”

should be investigated and 14% of respondents said that “allowing wider usage of the Recreation Ground changing rooms” should be investigated. Other ideas included: providing baby change facilities; offering the Hall to organisers of adult education activities so as to attract daytime (or evening) classes to the village; and making the Hall more of a social facility for older people in the parish (available for drop-in cups of tea at certain times etc). And there may be scope, too, to make better use of other community buildings (including the school, church and Seward Room) and to improve cooperation / coordination between them (e.g. a diary of availability).

Views and ideas on this matter had also been provided in Village Voice House Parties and workshops.

Views, information and ideas on this matter had also been provided in Village Voice House Parties and workshops.

The results of the Great Village Voice Questionnaire Survey show that the amount of dog muck in public places is one of the biggest worries that people have about our countryside and environment: 82% of respondents were either 'very worried', 'worried' or 'slightly worried' with only 18% being 'not worried at all'. 21% of respondents were very worried about this matter. Views, information and ideas on

this subject had also been provided in Village Voice House Parties and workshops. Particularly bad locations reported included the Recreation Ground and the footpath along the High Street between the village pond and the school.

## Action Plan E4

### Keeping footpaths, stiles and bridleways in good condition

#### Background

The results of the Great Village Voice Questionnaire Survey show that the condition of footpaths, stiles and bridleways is a major worry amongst the concerns that people have about our countryside and environment: 65% of respondents were either 'very worried', 'worried' or 'slightly worried' and a number of comments on this subject had also been provided in Village Voice House Parties and workshops. The Survey

had, however, revealed that a significant number of people would be willing to volunteer to help maintain footpaths and Rights of Way.

## Action Plan E5

### Improving the safety of pedestrians crossing the A3 Trunk Road

#### Background

The results of the Great Village Voice Questionnaire Survey show that the lack of safe crossings across the A3 is a major worry amongst the concerns that people have about our countryside and environment: 65% of respondents were either 'very worried', 'worried' or 'slightly worried'. A number of comments on this subject had also been provided in Village Voice House Parties and workshops, explaining that the forthcoming National Park is likely to lead to increases in walkers wishing to cross

the A3 between Buriton and Butser Hill / Weston and that the lack of a safe crossing point (or even signs warning motorists about the likelihood of pedestrians crossing) makes circular walks unattractive or impossible. A number of public footpaths and Rights of Way cross the busy A3 and, ideally, an underpass or footbridge is needed somewhere just to the north of the Buriton/Weston junction. At the very least, some warning signs for motorists should be considered

## Action Plan E6

### Reducing the visual impact of overhead cables

#### Background

The results of the Great Village Voice Questionnaire Survey show that the visual impact of overhead power cables (both in the countryside and in the villages) is a major worry amongst the concerns that people have about our countryside and environment: 72% of respondents were either ‘very worried’, ‘worried’ or ‘slightly worried’ about the visual impact of power cables in the countryside whilst 68%

were either ‘very worried’, ‘worried’ or ‘slightly worried’ about the visual impact of overhead cables in villages. A number of comments on these issues had also been provided in Village Voice House Parties and workshops

## Action Plan E7

### Reducing noise intrusion from the A3 Trunk Road

#### Background

The results of the Great Village Voice Questionnaire Survey show that noise from the A3 is a significant worry amongst the concerns that people have about our countryside and environment: 51% of respondents were either 'very worried', 'worried' or 'slightly worried' and a number of comments on this subject had also been provided in Village Voice House Parties and workshops. People have explained

that the noise can spoil the tranquillity of the countryside (a prospective National Park) as well as affecting significant pockets of residential properties – particularly in Weston. People felt that, when the A3 is next resurfaced, more modern, quieter road surface materials should be used.

## Action Plan E8

### Addressing noise from military helicopters

#### Background

The results of the Great Village Voice Questionnaire Survey show that noise from military helicopters is a significant worry amongst the concerns that people have about our countryside and environment: 53% of respondents were either 'very worried', 'worried' or 'slightly worried' and a number of comments on this subject had also been provided in Village Voice House Parties and workshops. Some people

explained that once they understood why low-level and night-flights were necessary they were more content and the intrusion was less of an issue for them. 47% of respondents were 'not worried at all' about this issue.

## Action Plan E9

### Reducing noise intrusion from train horns

#### Background

The results of the Great Village Voice Questionnaire Survey show that noise from train horns is a significant worry amongst the concerns that people have about our countryside and environment: 55% of respondents were either 'very worried', 'worried' or 'slightly worried' and a number of comments on this subject had also been provided in Village Voice House Parties and workshops. The issue clearly affects

some people (and some locations) much more than others as 45% of respondents were 'not worried at all' about this issue. For those affected, however, the disturbance can be a particularly significant issue with 20% of respondents being 'very worried'. In the survey responses, House Parties and workshops people have suggested a wide range of solutions to this problem which can be explored.

## Action Plan E10

### Addressing noise intrusion from late night events

#### Background

The results of the Great Village Voice Questionnaire Survey show that noise from late night events can be a significant worry amongst the concerns that people have about our countryside and environment: 46% of respondents were either 'very worried', 'worried' or 'slightly worried' and a number of comments on this subject had also been provided in Village Voice House Parties and workshops. Whilst only 7% of

respondents are 'very worried' about this issue it can affect particular pockets of properties much more significantly than others.

## Action Plan E11

### Felling and lopping of trees

#### Background

The results of the Great Village Voice Questionnaire Survey show that felling and lopping of trees is a major worry amongst the concerns that people have about our countryside and environment: 70% of respondents were either 'very worried', 'worried' or 'slightly worried' and a number of comments on this subject had also been provided in Village Voice House Parties and workshops. People were worried that there appeared to be an increasing tendency (in both public spaces and private gardens) to fell trees which may have a disease or a bit of dead wood, even if they

were not dangerous. With trees taking fifty or more years to grow, the attractive appearance of the village could easily be lost in a relatively short space of time. Some people suggested that regular checks should be undertaken, that the community should be consulted more frequently, that there should be more Tree Preservation Orders and that more new trees should be planted to compensate for any that are lost.

The results of the Great Village Voice Questionnaire Survey show that a gradual loss of tranquillity is one of the biggest worries that people have about our countryside and environment: 76% of respondents were either 'very worried', 'worried' or 'slightly worried' with only 24% being 'not worried at all'. 20% of respondents were very worried about this matter. Views, information and ideas on this subject had also

been provided in Village Voice House Parties and workshops with issues like local light pollution spoiling views of the stars at night-time and noise pollution (from traffic, trains, events and noisy recreational activities such as off-road vehicles and motorcycles) being amongst the problems reported.

The results of the Great Village Voice Questionnaire Survey show that damage caused to Rights of Way by motorised off-road vehicles (4X4s, motorcycles etc) is one of the biggest worries that people have about our countryside and environment: 87% of respondents were either 'very worried', 'worried' or 'slightly worried' with only 13% being 'not worried at all'. Almost four in every ten households (38%) said that they

were 'very worried' about this issue – the highest strength of feeling for any of the countryside and environmental issues explored in the questionnaire. Views and ideas on this matter had also been provided in Village Voice House Parties and workshops.

## Action Plan E16

### Exploring new amenities for the parish

#### Background

The results from the Great Village Voice Questionnaire Survey showed that there are relatively high levels of support for quite a number of new amenities in the parish. The levels of support for each of the following ideas (generally of the order of 52%) seems to suggest that they are all worthy of further consideration: making better use of the green (across the road from Buriton pond); restoring the old sheepwash by the village pond; a community orchard or garden; allotments; community composting; extended recycling facilities; and making more features of some of our streams.

In some cases, however, the small numbers of people opposed to the ideas (usually around 15%) may have very sound reasons for their views which could influence others if they were more widely known. A case in point may apply to the idea of community composting: whilst 48% of respondents said that 'yes', they would like to see this idea, a number of those saying 'no' explained that producing 'safe' compost was quite a difficult process if the spreading of penitious weeds (such as bindweed)


and diseases (such as potato blight) around the parish was to be avoided. Particularly high composting temperatures are required to ensure that weeds (even the common dandelion) are killed, and such temperatures are only generally attainable with vast volumes of compost. Risks from a community scheme (such as spreading weeds and diseases from one garden to another) could outweigh the benefits.

A small number of other historic features were suggested as ideas for restoration or attention: limeworks heritage in the chalk pits; other sheep pens, hop tanks and hydraulic rams. As in a number of Village Voice House Parties and workshops, people suggested that the stream from the Woolliff pond could be made to look nicer (for visitors to the cemetery) and that a small bridge could, perhaps, be provided over the stream onto 'Pond Green' and that this area could become more attractive for picnics etc.

## Action Plan E17

### The footpath over the railway line

#### Background

In the months prior to the Great Village Voice Questionnaire Survey there had been much discussion and debate about whether or not to close (or divert) the footpath that goes over the railway line from the Recreation Ground to the woods. The debate had focused on the safety of the crossing and the noise of the warning horns which are sounded as trains approach it. The Great Village Voice Questionnaire

Survey therefore sought information and views about the footpath: 62% of respondents use the footpath whilst 38% do not; 55% of respondents would not like to see the crossing over the railway line closed whilst 24% of respondents would like to see it closed (21% of respondents had 'no opinion' on this matter).

## Action Plan E19



### Initiatives to help local farmers

#### Background

At the Village Voice House Parties and workshops, people recognised that farming is vital to the future of our local landscapes and countryside. The Great Village Voice Questionnaire Survey asked for suggestions about how we might be able to help our local farmers and asked people two other questions on this topic. When asked if they would like to know more about our local farms / farming, 65% of respondents said 'yes'. When asked if they would support a farmers' market in the parish, 74% of respondents said 'yes', 9% said 'no' and 17% had no opinion. In addition, 45 respondents provided suggestions about how the community may be able to help local farmers which supplement ideas provided in Village Voice House Parties and

workshops.

Drawing on this information, the Village Voice Group has begun to design an initiative which would offer opportunities to improve the communications and understanding between local farmers and the wider community: traditional 'country code' messages can be supplemented with other messages about how residents (and visitors) can help by being 'eyes and ears' for farm crime and for animals in distress etc. There will also be important messages and understanding to promote about the increasing needs for farm diversification and about general benefits of 'buying British' rather than continuing to rely on imported foods.

## Action Plan E20

### South Downs National Park – maximising opportunities and minimising threats

#### Background

The parish of Buriton is likely to be in a new National Park for the South Downs within the next few years, promoting recreational uses of the area and encouraging conservation. A range of comments about this issue had been made in Village Voice House Parties and workshops. The Great Village Voice Questionnaire Survey asked people to think about ‘opportunities’ that a National Park could create for the

parish and to identify any potential ‘threats’ that a National Park might pose. There was a very healthy level of responses to both these questions with 74 households identifying potential opportunities and 84 households providing examples of potential threats.

## Action Plan D1

# Retaining the character of the villages and improving the effectiveness of the Village Design Statement

### Background

The Parish Plan project has been designed to, amongst many other things, help to update Buriton's Village Design Statement and so help ensure that any new development is designed and located to respect local characteristics and the qualities that residents value. From the comments received during the project, it appears that people feel that most of the Village Design Statement is still valid and important – but that there could be a few additions. *The Great Village Voice Questionnaire* Survey asked a number of questions to help improve and update the Village Design Statement.

At Village Voice House Parties and workshops people had explained that other villages are gradually losing their attractive appearances and local character because many small changes are made without adequate attention to detail (eg. inappropriate roadside kerbing, extra bits of concrete or tarmac for car-parking, stark garden walls and other things that remove the 'soft edges' of villages). In response to the Great Village Voice Questionnaire Survey, 93% of respondents said that 'it is important for everyone to pay attention to small details and to retain the character of our villages' whilst only 2% said that 'there is no need to encourage people to keep things in character, let them do whatever they want' (5% had no opinion on this matter).

Other results were as follows:

- 87% of respondents agreed that the entrances to the settlements are generally very attractive and that any new development should not detract from this situation
- 83% agreed that Buriton village is generally hidden from view as you approach it
- 82% said that if there is to be any traffic calming in the parish, it should look more in keeping with the character of the villages than the current examples in Buriton High Street
- 59% had worries about the visual effects of small wind-turbines being fitted to individual houses
- 54% of respondents felt that there are too many signs, too much clutter and that

signs should be rationalised and reduced

- 48% had worries about the sub-division of fields with extra fencing, sheds and shelters for pony paddocks.

The Questionnaire also sought examples of any recent developments in the parish that are felt to be out of character and of open spaces that are felt to be at risk and in need of safeguarding. 48 households provided examples of out-of-character developments (either specific locations or generic issues) with 23 of them citing one particular building. 55 households felt that there are some open spaces which may be at risk with the Links and adjacent fields behind Bones Lane being the most commonly cited, just ahead of the fields along Greenway Lane.

In the original survey for the Village Design Statement in 1999, over 80% of respondents said that they felt that the gap between the parish and Petersfield was important (to preserve the special identity of the local communities etc). The Great Village Voice Questionnaire Survey asked how people feel about this issue in 2007 and 92% now feel that it is important that the gap is preserved (6% had no opinion on the matter).

There were also other answers and comments from other parts of the Questionnaire that are relevant to the Village Design Statement including changes that spoil views from public paths, visual intrusion of overhead cables in the countryside and in villages, bright lights at night spoiling views of stars and damage to rural lanes by traffic.




Finally, the Great Village Voice Questionnaire Survey asked whether people felt that the planning authority pays sufficient attention to Buriton's Village Design Statement. 57% of respondents said that they did not know, 11% of respondents said 'yes' (that sufficient attention was paid) but 32% said 'no' (ie. they did not feel that the planning authority pays sufficient attention to the VDS).

## Action Plan D2

### New development in the parish

#### Background

The results from the Great Village Voice Questionnaire Survey show that, whilst 32% of respondents feel that the parish can support more housing development, 60% do not feel that it can (with 9% giving no opinion). With regard to commercial / industrial developments, 16% respondents feel that the parish can support more whilst 74% do not feel that it can (with 11% giving no opinion). The survey then asked “If there is to be more development in the parish, what sort of houses do you

think should be provided?” and people were asked to rank five alternative answers in order of importance: in joint first place (ie. considered to be the most important) were “affordable housing (by Housing Associations)” and “small family homes (up to 2 bedrooms)”; in joint third place were specialist housing (eg. sheltered housing for the elderly)” and “starter homes / flats”; and in fifth place (ie. least important) were “large family homes (3-4 bedrooms and above)”.

## Action Plan T1

### Improving public transport services and community transport

#### Background

The results from the Great Village Voice Questionnaire Survey show that members of about 20% of households in the parish can often or occasionally experience transport difficulties in getting to work, school/college or other places. Although not large in number, these can be very important difficulties. Getting to and from hospitals emerged as a particular concern. Users of the existing bus services

provided a range of information and ideas about improvements that they would like to see and a number of people volunteered to offer lifts and/or to help with a community minibus scheme. 94% of respondents felt that, if the bus service was to be withdrawn, the community should try to run a community minibus and 53% felt that the idea of a 'halt' for Buriton passengers on the railway line should be explored.

## Action Plan T2

### Addressing traffic and road safety issues

#### Background

The Great Village Voice Questionnaire Survey and the House Parties and workshops have provided a lot of valuable information about traffic and road safety issues. The main findings include:

- 64% of respondents felt that road safety is a problem in the parish
- 81% of respondents felt that the speed of traffic is a problem in the parish
- 69% of respondents felt that the size of vehicles on roads in the parish is a problem
- 66% of respondents felt that the number of cars bringing children to school is a problem
- 44% of respondents felt that there are road maintenance problems in the parish
- 61% of respondents felt that there is a problem with parking in the village
- 91% of respondents said that they support the idea that the traffic and parking situation along the full length of the High Street should be re-examined as a whole, to take account of traffic speeds, parking needs and the safety of pedestrians, schoolchildren and all road users
- 82% of respondents said that if there was to be any traffic calming in the parish then it should look more in keeping with the character of the villages than the current examples in the High Street
- 88% of respondents said that they would support the idea of creating some safer routes for pedestrians and cyclists (particularly for journeys to and from Petersfield and between Buriton and Weston) with the most commonly suggested ideas being: a footpath/cycleway alongside Greenway Lane into Buriton (or across the fields to Kiln Lane); and making Bolinge Hill Lane for pedestrians, cyclists, horses, access only (eg. putting a gate on it).





The Village Voice exercise has also collected lots of detailed comments about where parking is felt to be a problem, where the speed of traffic is felt to be a problem (with ideas for speed control measures) and about the locations of danger spots for motorists, pedestrians and cyclists.
